DISCUSSION

The state of Illinois offers a grant specifically intended for pedestrian access to schools. The Highland Community Schools, and the City, would greatly benefit from constructing a new shared use path along Poplar St. to the new primary school. Currently, there are no sidewalks south of VFW Road. The grant pays up to \$250,000 towards the construction costs. The passing of this resolution is required by the grant application to be considered.

WHEREAS, the Mayor and City Council have considered the City's participation in the Safe Routes to Schools Grant Program and determined that it is in the best interests of the City and its residents to enter into the program for the benefit of the projects.
