Mayor Hemann read a document proclaiming the week of May15 through 21, 2022 as EMS Week and presented to EMS Chief Brian Wilson. Mayor Hemann stated he and City Manager Conrad met with EMS Staff and presented several of them with service awards.

Mayor Hemann read a document proclaiming the month of May 2022 as Motorcycle Awareness Month on behalf of the local A.B.A.T.E. organization.

# **PUBLIC FORUM**

# **Citizens' Requests and Comments:**

St. Paul Catholic Church – Kirchenfest – Special Event Application and Road Closure Request – Linda and Keith Hagler, Representatives, were present to request permission to host Kirchenfest, August 26-28, 2022. Councilwoman Bellm asked if the flea market is back. Mr. Hagler replied yes. Councilwoman Bellm expressed great, because I have a lot of stuff to drop off for it. Councilwoman Bellm made a motion to approve St. Paul Catholic Church's request to hold Kirchenfest, August 26-28, 2022 per all the requests in the special event application as attached. Motion seconded by Councilman Frey. Roll Call Vote: Councilmembers Sloan, Frey, Bellm and Hipskind voted aye, none nay. Motion carried.

Highland Music School and Louis Latzer Library - Learning Concert - Special Event Application - Due to no one present to speak on this request, the council decided to hold it until the next meeting.

VFW Post 5694 and American Legion Post 439 – Memorial Day Parade – Special Event Application – Kate Broadhurst requested permission to hold the Memorial Day Parade on Monday, May 30, 2022. We will be back to doing our normal ceremonies at the various cemeteries that day, starting at St. Joseph's Cemetery at 9:15am, Highland City Cemetery, 9:45am; and, Grantfork, 10:30am. Parade lineup will be at St. Paul's Church Parking Lot at 12:30pm with step-off at 1:00pm, and end at VFW Post 5694. To assist with this we are requesting \$200 to offset the cost of the high school band. Councilwoman Bellm made a motion to approve the VFW Post 5694 and American Legion Post 439 request to hold the Memorial Day Parade, on Monday, May 20, 2022 as attached. Motion seconded by Councilman Frey. Roll Call Vote: Councilmembers Sloan, Frey, Bellm and Hipskind voted aye, none nay. Motion carried.

Linda Iberg, President of Ladies' Auxiliary of American Legion Post 439 stated we are here to kick off our annual Poppy Campaign. We distribute the poppies over Memorial Day weekend. If you want to give a donation, you can. The donations made go to support veterans at the local hospitals. She presented the mayor and council with a plaque for support of the poppy campaign over the years.

Mayor Hemann noted he was at the Madison County Recorder's Office today. They are working to set up a program for discounted services for veterans. He asked if he could call Kate, in a couple of weeks, when he had more information. Ms. Broadhurst replied yes. There are four of us on the veterans' assistance committee.

Jerome "Blackie" Kuhl expressed we are not smart enough to play the national anthem up on the square. We spend a fortune on police and fire station over here, but we cannot do that. Why don't we just play it over there? There are people over there at all times of the day. You decided that the city cannot spend money for the 1-2% in Highland, but spend money on the Square. So why not spend money to play it from the fire station? Mayor Hemann responded we discussed it and decided it is not something we choose to do. I understand your request and it is very admirable. However, it is not feasible to take city employees and resources to play it daily. We are very aware of our veterans. Mr. Kuhl pointed out some people died for this town. They did not have a choice. Mayor Hemann stated I know you feel we are not doing what you want. We have to do what is best for all the citizens and focus our services and resources on those things. Mr. Kuhl suggested move it to the fire station. People there all the time. I know you feel I am foolish. I was one of the fortunate ones, because they recognized me. The golf carts I was wanting for people riding around in wheelchairs and strollers. You guys don't feel that is important. You just don't want to talk to people. Mayor Hemann contended my door is open to talk. Chris has agreed to meet with you each Monday. While you feel we are not doing things to please you, we are doing things. We made a decision that we are not going to do this. Mr. Kuhl stated well tell people your kid died for nothing.

# Requests of Council:

## Staff Report:

City Manager Chris Conrad reviewed the grass and weed control policy, and how we handle it. The first week of each month, on Wednesdays, we split staff in half and tour town. We leave notice to those in violation. Anything not cut after the following Thursday, the city crews cut grass, as this is seven days after notice, and owners are assessed a fine.

Discussion on Purchasing Policy - City Manager Conrad reported the city's purchasing policy was implemented last year. There have been no changes in state statue associated with this. Under \$1500 is at the discretion of the director. \$1,500-\$24,999 requires director and city manager's approval. Anything over \$25,000 requires council approval. Purchases \$1,500-\$5,000 require three verbal quotes;

\$5,000-\$24,999 requires a written quote and signed purchase order. Examples of sole-serve purchases would be those from government agencies or only obtainable from the manufacturer or designed distributor.

The Wall Street Journal closing was a loss, as that was a big fundraiser for us. Councilwoman Sloan reported they have been going around to the different organizations to seek support also.
